I refer to your letter of 3 April 2019 seeking an update on Ulan Coal Mines Limited's (UCML) progress in securing the Bobadeen Offset Area and Bobadeen East Offset Area. Ulan provides the following response:

- UCML's directors signed the two Conservation Agreements on 11 January 2019;
- the signatures of the lessee, which were required to finalise the Bobadeen Conservation Agreement, were obtained on 9 April 2019;
- the Conservation Agreements for the Bobadeen Offset Area and Bobadeen East Offset Area were couriered to NSW Biodiversity Conservation Trust (BCT) on 9 April 2019 and the BCT has confirmed that the agreements are now in the process of being finalised by the BCT; and
- in terms of that finalisation process, the NSW Minister for Energy and Environment must also now sign the documents and then they need to be registered on the property title.

UCML understands that, following the recent NSW election, it may take some time for the new ministers to be briefed fully on their portfolios and relevant matters. As such, UCML is not aware of the likely timing for the agreements to be signed by the minister. Once this does occur, UCML will act promptly to register the agreements on the property title.
