Below is a brief status update on your request for advice on acoustic disturbance.

As we discussed at the end of November, AAD has been focusing our advice on three whale species for which there is Departmental conservation advice: blue, humpback and southern right whales. Even after restricting our advice to these species, we have found that the scope of the request and nature of our reply has entailed more effort and a longer timeline than we initially anticipated

The nature of our advice has largely taken the form of a literature review of behavioural disturbance. Building on past work, we have framed our review as an update to the chapter on behavioural disturbance in the comprehensive Southall et al (2007) volume of Aquatic Mammals. At this stage, we have completed a draft of the following advice (attached):

- · A bibliography of primary literature on behavioural disturbance, but focused on baleen whales, particularly the three species above (since 2007-present).
- · A background section providing a summary and context of recent methods and approaches for assessing behavioural disturbance (2007 present).
- · A summary and review of literature on behavioural disturbance of blue whales
- · A review of a recent article on the "Population Consequences of Disturbance" for north pacific blue whales. This is was a proxy for the requested "synthesis of current knowledge regarding their relative vulnerability to noise"

However, due to the volume of literature published recently on humpback whales, we have not yet completed advice regarding humpback whales nor southern right whales, although we have written substantive draft text written for each of these species. As we've mentioned, on Friday (18 Jan) see and I will be boarding RV Investigator to lead whale research teams on a 49 day voyage. As such our group will have limited capacity to continue working on this (or any other) advice until we return in mid-March. Given our prior commitments, we anticipate that the earliest we could complete this advice would be the end of March, though this may require some compromise on the comprehensiveness/thoroughness of our advice. A deadline of mid-April would allow us time to ensure that our advice is higher quality and more comprehensive. Our apologies that we haven't been able to meet your original deadlines for this request, but we really appreciate your flexibility and willingness to help accommodate our busy schedules. Thanks for the update on the advice preparation and I hope you had an enjoyable New Year too. From a quick read of the draft advice it is looking good and provides some relevant and contemporary scientific context on sound disturbance to whales in a concise manner. It is useful to see the number of new papers published since the Southall work for the 3 key species as it indicates there is a need to understand how scientific understanding has changed. We will be particularly interested in understanding if the new science indicates a need to change the way impacts of behavioural disturbance are assessed and managed, e.g. new evidence indicating particular species or behaviours of relevance to Australian waters are more or less sensitive than previously understood. We understand the challenges in deriving hard and fast numbers/sound levels to inform management and recognise that gaps/uncertainties will remain. In this respect, one suggestion for the further development of this work is to summarise the literature review with some conclusions that relate back up to one of the key questions in our advice request, i.e. what are the levels of underwater noise considered to cause behavioural disturbance to the extent that animals may be displaced from a biologically important area or do not continue biologically important behaviours (e.g. migration, feeding, breeding, calving, resting). We understand that this is likely to require some extrapolation across species/regions etc. and there will not be a simple one size fits all answer but this would be useful where considered valid/possible.

All the best for the research voyage and perhaps we could touch base on your return to discuss timeframe for completion as we will then have a better understanding of what decisions we have on the books and whether there is any urgency in the advice or particular aspects of the advice. The nature of our advice has largely taken the form of a literature review of behavioural disturbance. Building on past work, we have framed our review as an update to the chapter on behavioural disturbance in the comprehensive Southall et al (2007) volume of Aquatic Mammals. At this stage, we have completed a draft of the following advice (attached):

- · A bibliography of primary literature on behavioural disturbance, but focused on baleen whales, particularly the three species above (since 2007-present).
- · A background section providing a summary and context of recent methods and approaches for assessing behavioural disturbance (2007 present).
- · A summary and review of literature on behavioural disturbance of blue whales
- · A review of a recent article on the "Population Consequences of Disturbance" for north pacific blue whales. This is was a proxy for the requested "synthesis of current knowledge regarding their relative vulnerability to noise"

However, due to the volume of literature published recently on humpback whales, we have not yet completed advice regarding humpback whales nor southern right whales, although we have written substantive draft text written for each of these species. As we've mentioned, on Friday (18 Jan) s22 and I will be boarding RV Investigator to lead whale research teams on a 49 day voyage. As such our group will have limited capacity to continue working on this (or any other) advice until we return in mid-March. In this respect, one suggestion for the further development of this work is to summarise the literature review with some conclusions that relate back up to one of the key questions in our advice request, i.e. what are the levels of underwater noise considered to cause behavioural disturbance to the extent that animals may be displaced from a biologically important area or do not continue biologically important behaviours (e.g. migration, feeding, breeding, calving, resting). We understand that this is likely to require some extrapolation across species/regions etc. and there will not be a simple one size fits all answer but this would be useful where considered valid/possible.
