Section 5.4 of the plan requires the following: 'Confirm and identify the spatial extent and condition of threatened species habitat to be disturbed, within 12 months prior to any clearing or disturbance commencing, through pre-clearance surveys, focusing on species that were not detected during field surveys for the EIS'.


