The Department is finalising its review of the revised draft PD, noting it is still a comprehensive main document and a large number of issues were identified in regards to the initial draft PD. There is also considerable updated information in the revised draft PD that requires review and to ensure it is consistently applied throughout the entire revised draft PD. The Department does acknowledge that Adani has undertaken substantial work to address the Department's comments – in particular removing references to the Stage B pipeline outside of the project description section and updating habitat descriptions.

However, the Department has identified several issues which it considers have not been adequately addressed in the revised draft PD, in particular:

- clear alignment of some habitat descriptions with Commonwealth requirements and the request for additional information, including linkages with field-derived information;
- a lack of committal language regarding key avoidance, mitigation and management measures;
- clarification of aspects of the proposed environmental offset to ensure it aligns with the principles of the Environmental Offsets Policy;
- general administrative issues, in particular updates of maps to align with the updated information and reduce duplication; and
- based on the information available, the Department is still of the view that potential residual significant impacts on other listed threatened species (e.g. Squatter Pigeon) are likely to occur as a result of the project.

**Next steps**

The Department anticipates adequacy review comments will be provided early next week – as noted above, the scope of the comments have been narrowed considerably. To assist and noting limited staff availability, the Department is open to organising a meeting on **7 or 8 January 2021** to provide context to the comments, discuss options for how Adani can best address the comments in a timely manner and align next steps of the assessment process.

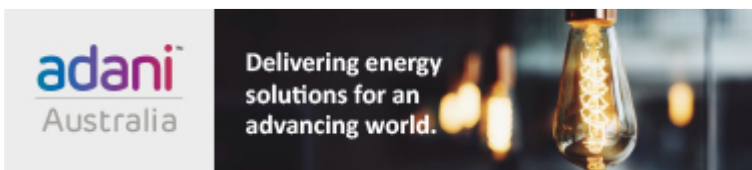

The Department has undertaken a preliminary review of Adani's responses to the Department's comments on the draft PD (version 1) and notes that Adani has updated the draft PD to address the majority of the comments. I note there are several key sections of the revised draft PD which require further detailed review by the Department to ensure the RFI has been adequately addressed and there is sufficient information for the Minister (or delegate) to make a legally robust decision under the EPBC Act.
