Good afternoon

Could OPVs please forward the following onto plant management / QA managers and discuss the following with establishment management as part of their next weekly meeting. Note, ATMs will also be following up with plant managers next week to discuss.

Re: Ongoing point-of-entry failures to the USA

In October 2020, the department wrote to all establishments to highlight an increase in point-of-entry failures to the USA.

Despite this advice, there continues to be point-of-entry failures to the USA, with an ongoing trend in the detection of faeces and ingesta on meat products. The number of point-of-entry failures since the beginning of 2020 (10) has been highlighted by US FSIS as a concern. The Department reminds establishments of the importance of Australia's reputation as an agricultural producer of clean and safe product.

It is critical that our regulatory system continue to assure our trading partners that Australian agricultural products meet import requirements. In response to specific US concerns, I have requested OPVs undertake additional verification activities for small stock carcase and boning room ZTs.

I remind you that it is the responsibility of establishment management to ensure that products that are being produced for export are clean and consistently comply with Australian Standards and importing country requirements. Failure to comply with these requirements is likely to result in increased importing country scrutiny and intensified port assurance activities - as well as having the potential to result in a requirement for increased assurance activities such as increased numbers of carcasses subject to company verification checks.

Ultimately a failure to reduce ZTs could result in the US imposing sanctions, losses in confidence in Australia's export system and/or potential losses in market access for the US and other significant markets.
