I unwrapped the item and examined it. It appeared to be a real skull decorated with stuck on stones etc. I suggested to the pax that it was a real skull and not wood. I showed him the teeth and skull plate joins and he said that he hadn't really looked at it closely. I referred the item to Border Force for CITES appraisal. ABF seized the item and filled in hardcopy paper work. The skull is wrapped securely and labelled.
