From Farmers for Climate Action CEO Natalie Collard:

"I first worked with NTCA since my time leading rural affairs for NFF in 2007 and I have the greatest respect for the farmers and graziers of the NT. Since beginning this job, I have reached out to collaborate and invite NTCA members' views to be reflected in our work and that door remains open.

"Farmers for Climate Action is proud to represent 8000 farmers from right across Australia who are clothing and feeding Australia and the world. We were created in 2016 by a group of 30 farmers who felt traditional farming groups were not representing them on issues around climate change. Our membership has grown from 30 farmers to what it is today, based on the work we do. Our Chair, Brett Hall, is a fourth generation beef farmer and former Cattle Council board director. He is also one of our original founding farmers.

"As one example of the broad membership of Farmers for Climate Action, respondents to our recent farmer survey reflected the make up of commodities across states and territories, very closely aligning with the ABS agricultural commodities data from 2023. Beef farmers were the biggest cohort of farmers who filled out the survey, followed by sheep (meat and wool) and grains - a similar split to the latest ABS data. Farm sizes ranged from 1 ha to 430,000 ha, and the number of employees on-farm ranged from 0 to 420.

"We're proud to offer memberships which are not tied to funding and demonstrate our value to farmers through results, although many of our farmers choose to make a financial contribution by choice. We connect very regularly with our farmers through local groups and events run by our farmers, emails, webinars, surveys, them ordering signs from us, training and other initiatives. We know our members are farmers because we deal with them regularly. Our team also connects with our farmer members directly and regularly to inform our work.

"In order to join, members click through our website and are asked to confirm they are a farmer and supply their name, contact details and postcode before clicking the "join" button. Supporters and followers click through and are also asked to supply their name, contact details and postcode.

"We understand it's been extremely difficult for some farm groups who charge membership fees to attract members, and membership is something all agricultural organisations grapple with. We're funded mostly by philanthropic donations, from both farmer donors and from some of the best-known and most recognised charitable trusts in Australia. We can confirm beef farmers are our largest commodity represented membership and that we enjoy a good eye fillet.

"In our view, all farmers deserve respect, and our goal is that every farmer in Australia today is able to farm forever - profitably, productively, supporting our people and planet. Farmers need to stick together, not tear each other down."

Program Proposal

Executive Summary

The Climate Smart Farming Program (CSFP) is an initiative by Farmers for Climate Action aimed at supporting Australian agriculture to broaden and hasten the on-farm adoption of sustainable, profitable climate smart practices with confidence.

The CSFP seeks to fortify the farming community against the impacts of climate change with best practice adaptation, mitigation and innovation practices, while also aiding in achieving Australian agriculture's net-zero ambitions and long term commercially viable farming.

Our goal is to enable Australian agriculture to achieve our vision of Farming Forever. Recognising that each farm business is different (one size does not fit all) and every farm business is at a different stage in their adaptation journey, the CSFP embraces a combination of eleven initiatives to offer value for every Australian farmer.

These initiatives fall under the themes of:

- Investing in Climate Smart Farming Skills
- Addressing Climate Smart Research and Knowledge Gaps
- Strengthening Climate Smart Farming Leadership, Community-Building & Extension
- Celebrating Australian Agricultures' Climate Smart Farming and Farmers

Program Components

Investing in Climate Smart Farming Skills

1. Climate Smart Farming Scholarship (\$130k p.a)

The Farmers for Climate Action Climate-Smart Farming Scholarship is a ground-breaking national capacity building and leadership program designed specifically for Australian farmers.

Over 10 months, the Scholarship will be offered to 20 leading farmers drawn from across Australia and across a wide range of industries.

Alongside the Farmers for Climate Action Climate Leaders Network, the program will bring these farmers together to deliver targeted training in carbon neutral and climate focused agricultural practices - designed to illustrate the pathway to reducing carbon pollution in the ag sector - that can then be implemented and shared within their own communities.

In addition, specialist media and advocacy training will develop an informed and impactful cohort of Australian farmer advocates who can speak with authority on the benefits climate-smart agriculture offers to farmers and farming communities, in their communities, in industry and in MP offices.

Our vision is that each year the Climate Smart Farming Scholarship provides fully funded access for 20 of the nation's leading farmers to the country's leading climate-smart professional development program.

Inclusions are:

- Carbon neutral agriculture training + carbon audit of their farm [Melbourne Uni course]
- Climate Essentials for Ag [ANU course]
- Participation in the FCA Climate Leaders Network, engaging with other farmers taking climate leadership across Australia

- Monthly facilitated dialogue
- Canberra retreat, including:
 - Accounting for Nature - 1 day course
 - Join CSFP flagship event at Parliament House in Canberra

Addressing Climate Smart Research and Knowledge Gaps

2. Climate Smart Farming Toolkit (\$20k p.a)

[Refresh the existing CSF Toolkit and add up to 10 more]

3. Climate Smart Farming Report / Research (\$50k)

An annual report focused on climate smart farming. This may include a focus on a key area requiring resolution to remove barriers to adoption; data development and promulgation; and/or showcasing success methodologies and stories to promote wider adoption.

- Usable by industry

Strengthening Climate Smart Farming Leadership, Community-Building & Extension

4. Regional Events (min. \$10k p.a)

8 x Regional Roadshow Events empowering farmers with knowledge on renewables, electrification, regeneration, biodiversity, and more. These discussions are interactive and intended to cover each state and territory over a 3 year period.

5. Farmer in Focus Case Studies (min. \$20k p.a)

10 x case studies showcasing a range of commodities, farm sizes, investment sizes, starting points and geographical locations.

6. Free Webinars (min. \$25k p.a)

5 x webinars on key issues related to Climate Smart Farming, including barriers and incentives to uptake. Topics may range from transmission, regeneration, electrification,

insurance, and international and national standards and compliance approaches.

7. Climate Leaders Network (min. \$7k p.a)

10 x farmers upskilled as Climate Smart Leaders through media training and added to the FCA Climate Leaders Network along with scholarship participants.

8. Events and Presentations (approx. \$15k p.a)

10 x supported speaking engagements in regional communities for FCA Climate Leaders to present to events nationally where farmers are present to promote climate smart farming practices from their perspective.

9. Social Media and Communications Extension & Training (\$30k p.a)

Climate Smart Farming Social Media two online workshops x up to 20 farmers to support farmers to effectively communicate to their wider community that farming is sustainable and responsible long term. In addition, a twelve-month communications program raising awareness of the CSFP activities, toolkits and promoting participation and uptake.

Celebrating Australian Agricultures' Climate Smart Farming and Farmers

10. Australian Agriculture Climate Smart Farmers Flagship Event in Canberra (\$45k p.a)

An annual event at Australian Parliament House in Canberra with 20+ climate smart farmers, Program Partners and supporters to connect with decision-makers, media and each other to celebrate the practical steps being taken by Australian farmers to address climate change and support long-term food production, land stewardship and biodiversity.

11. FCA Member of the Year Award (\$4k p.a)

A new award recognising outstanding contributions to promoting climate smart farming in Australia through volunteerism to be presented in Canberra at the flagship Climate Smart Farmers event.

Funding Model:

A 3-year funding commitment is proposed to create a culture of long-term climate action, leveraging partnerships with commercial entities and stakeholders in the agricultural supply chain.

These entities, strategically aligned with FCA's sustainability and climate action ambitions, can pledge support across four tiers:

Platinum Tier: **s. 47G(1)(a)** annually / 3-years

- o Deliverables: Featured partnership branding, up to two scholarship positions for suitably qualified farmer applicants, opportunity to provide a qualified speaker for webinars and other engagements, opportunity to provide expert input to reports and research, invitations to exclusive FCA events, reports on impact, and a speaking role at the annual CSFP event.

Gold Tier: **s. 47G(1)(a)** annually / 3 years

- o Deliverables: Partnership branding on select FCA initiatives, annual reports on impact, and access to FCA research.

Silver Tier **s. 47G(1)(a)** annually / 3 years

- o Deliverables: Logo placement on FCA communications, annual impact overview, and discounted access to FCA events.

Bronze Tier **s. 47G(1)(a)** annually / 3 years

- o Deliverables: Acknowledgment in FCA annual reports and newsletters.

Non-profit & Education Partnership Category:

Non-profits aligned to the CSFP objectives can also pledge in-kind contributions, such as speaking opportunities at events, services, resources, or expertise to support the CSFP deliverables. In return, they receive invitations, acknowledgment in FCA events and materials. In-kind partnerships can include:

- o Development in accordance with FCA guidelines and consultation of 3 farm in focus pieces per year;x
- o Speaking opportunities for FCA or FCA farmers at your event;
- o Promoting FCA membership, donations and participation in the CSFP to your network;
- o Participation in the selection process for FCA Member of the Year
- o Expert contributions to reports, sharing of research and data.
- o Other?

Education Partners may contribute discounted courses, access to expert speakers, students and research.

Value to FCA

1. Advocacy independence: the separation of FCA's political advocacy work and voice from the CSFP enables FCA to accept funding from more sources, such as commercial partners, (in line with our policy) without creating a risk of being seen to compromise or risk our independent voice.

2. Funding Diversity: Multi-year commitments ensure diversified and consistent funding. A funding vehicle such as the CSFP is sufficiently broad to offer cross-sectoral value, with exclusivity offered at each tier per sector. This model may be attractive to philanthropics who prefer partial-funding models alongside industry. The in-kind provisioning enables partnerships with Research and Development Corporations and other partners that currently are not closely linked with FCA's work.

2. New Income Sources: By reaching out to the broader agricultural supply chain, FCA taps into previously untapped sources of commercial income. This enables key philanthropic and large-scale grants and donations to be used towards core work such as strengthening advocacy.

3. Demonstrating Impact: The CSFP will serve as a visible testament to FCA's dedication and tangible work to drive and promote climate action within agriculture.

4. Membership Value and Growth: The CSFP offers a valuable opportunity to farmers nationally with low-thresholds of participation, strong alignment to farmer value and helps bridge the gap between vital advocacy *about* farmers to support *for* them.

5. 'Mainstreaming' Climate Action: Collaborating with commercial entities as well as agricultural research and development bodies will strengthen FCA's mainstream ties and enhance FCA's strong position amongst politicians and groups such as the NFF (in line with our theory of change)..

6. Sustained Commitment: With rolling, multi-year funding, existing successful initiatives such as the Climate Smart Scholarships are moved from insecure funding year on year to secured for three-year periods. This is vital to ensure continuity and growth, as well as to manage risk due to the low number of potential funding sources for this initiative and their disinclination to be funding the initiative year on year despite the positive impact. Critically, new partners can be on-boarded at any time in the three year period.

7. Servicing efficiency:

The CSFP draws mostly on existing programs already serviced and delivered and serviced by FCA staff. The model will be delivered when a baseline of funding is achieved (eg. delivery at cost, however as it grows it can and will make a profit for FCA and support ongoing reserves for future delivery).

Fundraising Director supported by CEO and Strategy Director to lead initial

conversations and sign on, with a range of staff to hold relationships with delivery partners ongoing (especially with respect to non-profits). Servicing load is less than individual grant and philanthropic applications as each partner is signing on to a pre-agreed set of deliverables and will ideally be led by a position wholly or partly funded by the Program itself.

Benefits to Partners

Brand Alignment & Customer Value

Partners demonstrate their commitment to sustainable farming practices and the long-term sustainability of farming in Australia, enhancing corporate image.

Farming Customers can directly and indirectly benefit from each element of the program.

Exclusive Access

Higher-tier partners gain unique early insights on research, access to speakers for key events, and networking opportunities.

Employee Engagement

Employee surveys consistently demonstrate that authentic, genuine sustainability initiatives are an important driver of employee engagement and satisfaction.

“70% of respondents said it is important or very important for Australian organisations to focus on ESG activities. The primary reasons are because it is the right thing to do (59%), to meet customer expectations (59%), and to meet employee expectations (50%).” source: www.bcg.com/publications/2021/australian-employee-perspective-esg

Workplace giving (if included) may also foster a culture of giving, boosting employee morale and corporate culture.

Collaborative Impact

Partners become part of the solution, shaping the future of sustainable agriculture.
