All goods identified in the INSPECTION or INSPECTION & ANALYSIS REQUIRED section of this Food Control Certificate must be fully unpacked and available and the importer or agent present at the time of inspection.

For sampling of oversized and/or frozen food items importers are requested to assist by providing a representative, who may be required to use sampling tools, to take the sample under the supervision of an authorised imported food officer. Please ensure this support is available prior to booking your inspection. All documents must comply with the department's minimum documentary and import declaration requirements policy. Failure to comply with these Additional Directions may result in the inspection being cancelled.
