#### ADANI - NORTH GALILEE WATER SCHEME - TALKING POINTS

## **Key Points**

- Adani Infrastructure Pty Ltd has referred a proposal under the Environment
   Protection and Biodiversity Conservation Act 1999, to construct and operate a water
   pipeline (the 'North Galilee Water Scheme') to provide a water supply under a
   commercial agreement to the proposed Carmichael Coal Mine and potentially in the
   future, other resource projects in the northern Galilee Basin.
  - The proposal involves the construction of a pump station, water storage infrastructure, 110 km of buried pipe line, and upgrading an existing storage dam from 2.2 gigalitres to 10 gigalitres (see map at Attachment 1).
- The referral has been published for a 10 day public comment period until 25 June 2018.
- After that public comment period, a decision will be made on whether the proposal requires further detailed assessment under the EPBC Act.
- Under the EPBC Act, proposals are required to undergo an environmental impact assessment if they are likely to have a significant impact on defined matters of national environmental significance.
- The EPBC Act process is separate to any approvals required by the State.

## If asked - is Adani avoiding federal scrutiny of water-related impacts?

- Under the EPBC Act, large coal mines that have a significant impact on a water resource (the 'water trigger') must undergo an environmental assessment of those impacts.
- The North Galilee Water Scheme proposal has been referred separately to the approval under the EPBC Act for the Carmichael coal mine.
- A decision is due by 6 July 2018 on whether the proposed North Galilee Water Scheme requires further detailed assessment under national environment law and, if so, which nationally protected matters will be required to be considered during the assessment process, including whether the water trigger applies to this proposal.
- The water related impacts of the Carmichael coal mine itself have already been subject to a detailed assessment under the EPBC Act.
  - The Carmichael Coal Mine and Rail Project was approved on 14 October 2015 under the EPBC Act.
  - The approval of the Carmichael Mine Project includes strict conditions that address advice from the Independent Expert Scientific Committee on Coal Seam Gas and Large Coal Mining Development. The conditions of approval fully respond to the recommendations in this advice.
  - The Carmichael Mine Project approval includes conditions for the protection of water, including a requirement for comprehensive groundwater management plans and strategies to be prepared and approved by the

Minister before mining can commence and a requirement for Adani to offset the predicted annual water take of the mine. This will be achieved by reducing extraction from the Great Artesian Basin by 3 650 megalitres per year, to be implemented over the first five years after coal mining commences.

### If asked - how does the water trigger work under national environmental law?


- The water trigger allows the impacts of proposed coal seam gas and large coal mining developments on water resources to be comprehensively assessed at a national level.
  - Such a proposal may have a significant impact on a water resource if there is the possibility that it will directly or indirectly result in a change to the hydrology or the water quality of a water resource.
- Stand-alone proposals which involve only associated infrastructure, such as
  processing, pipelines, rail lines and other transportation facilities, would not be
  captured by the water trigger, as these are non-extractive activities.

## **Background**

- The North Galilee Water Scheme is located approximately 160 kilometres north-west of Clermont in Central Queensland.
- The proposal will harvest a portion of the flood waters from the Suttor River and pump it via a pipeline to a water storage dam for use in resource-extraction projects in the northern Galilee Basin.
- The proposed disturbance footprint of the proposal is approximately 500 hectares.
- The Queensland Government has already issued Adani a water licence to extract up to 12.5 billion litres (12.5 gigalitres) of surface water a year, in addition to a groundwater licence to dewater the mine.

# Request for additional information North Galilee Water Scheme, Galilee Basin, Qld

Thank you for submitting a referral under the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act) concerning the above proposed action.

An initial examination of your referral indicates that there is insufficient information to allow the Department to consider all the relevant issues.

Could you please provide the following further information:

- details of how the proposed action relates to water supply infrastructure approved under EPBC 2010/5736, including but not limited to the proportion of water harvesting that will occur from the Belyando River and the Suttor River;
- provide data to show the seasonal flow regime for the Suttor River at the proposed harvest location;
- a description of geomorphological conditions downstream of the proposed water harvest site. This should include the location of any permanent or semipermanent pools that may support habitat for matters of national environmental significance;
- details of how the proposed action is likely to impact species and ecological communities downstream of the proposed harvest location. Species that must be considered include, but are not limited to, Brigalow (*Acacia harpophylla* dominant and co-dominant) ecological community, Koala (*Phascolarctos* cinereus), Squatter Pigeon (*Geophaps scripta scripta*), and Ornamental Snake (*Denisonia maculate*); and
- a copy of the Queensland Water Licence (reference 617268) including any conditions.
