PLANT BIOSECURITY POLICY MEMORANDUM 2002/39

POLICY REVIEW - FRESH PAPAYA FROM FIJI

The purpose of this Plant Biosecurity Policy Memorandum (PBPM) is to notify you of the availability of a *draft review of quarantine requirements for the import of Fijian papaya to Australia*.

Plant Biosecurity Policy Memorandum (PBPM) 2002/35 of 14 August 2002 advised stakeholders of the public meetings that were held in Mareeba and South Johnstone on 20 & 21 August 2002 respectively to discuss this review of existing policy.

A draft review of quarantine requirements for the import of Fijian papaya has been prepared. The purpose of the review is to provide information on:

- · import conditions for Fijian papaya
- the export pathway
- · the phytosanitary certificate
- audits to be conducted by the Fijian Ministry of Agriculture, Sugar and Land Resettlement
- · inspection of papaya on arrival in Australia and
- · pests and diseases of quarantine concern.
