**PLANT BIOSECURITY POLICY MEMORANDUM 2004/14**

**POLICY DETERMINATION ON THE IMPORTATION OF FRESH MANGOSTEEN (*GARCINIA MANGOSTANA*) FRUIT FROM THAILAND**

This Plant Biosecurity Policy Memorandum (PBPM) advises stakeholders of the final policy determination to allow the importation of fresh mangosteen (*Garcinia mangostana*) fruit from Thailand.

Biosecurity Australia notified stakeholders in PBPM 2004/01 of the release of the final import risk analysis (IRA) report on the importation of fresh mangosteen (*Garcinia mangostana*) fruit from Thailand on 10 February 2004.

Stakeholders were given the opportunity to appeal to the Import Risk Analysis Appeal Panel (IRAAP) – a body that is separate from Biosecurity Australia. Two appeals were received during the appeal period. Following consideration by the IRAAP the two appeals were disallowed.

The final policy determination to allow the importation of fresh mangosteen fruit from Thailand, incorporating conditions outlined in the final IRA report, has now been made by the Director of Animal and Plant Quarantine. Biosecurity Australia will notify the Australian Quarantine and Inspection Service (AQIS) of the new policy and AQIS will publish the import conditions on the AQIS website ([www.aqis.gov.au/icon](http://www.aqis.gov.au/icon)).
