New Caledonia	Horse meat and horse meat products	1.3, 7.1	New agreed certificate formalised to facilitate ongoing trade in this product.
Iraq	Farmed deer and camel meat	1.3, 3.1, 7.2	New market access, including agreed certification, has been established to enable trade in this product to commence.
Lebanon	Green runners	5.1, 8.1	New agreed certification to allow sourcing of product from animals which have undergone ante- and post-mortem inspection.
PNG	Poultry meat and poultry meat products	7.1	Certification for uncooked mechanically deboned poultry meat (MDM) has been exempted from PNG's ongoing ban on uncooked poultry meat and poultry meat products.
Republic of Korea	Poultry meat, poultry meat products and edible offal	7.1	Revised certification has been established allowing trade to recommence.
Indonesia	Pet food and rendered meals	8.3, 8.5	Certification for pet food and rendered products containing poultry has been reinstated following Indonesia's lifting of avian influenza related restrictions.

<u>Upgrade to the Manual of Importing Country Requirements (MICoR)</u>

From 11 April 2015 the Department of Agriculture (the department) has upgraded the MICoR website, and as a result you will now access it through a new URL.

http://micor.agriculture.gov.au

Your user name has not changed. When you access the new website for the first time, you will need to reset your password. To do this, follow these instructions:

Go to http://micor.agriculture.gov.au

Select your commodity of interest (e.g. Meat or Diary). Please note logins are not required for fish, eggs and non-prescribed goods.

Click 'Login'

Click on 'Reset Password'.

Enter your user name into the field and then enter a four digit PIN. Click 'Send Instructions'.

An email with further instructions will be sent to your email address. Follow the instructions within the email to reset your password.

If you currently have accounts for multiple MICoR commodities, you only need to follow the process described above once. i.e. resetting your password for Meat will also reset your password for Dairy.

If you do not have access to MICoR, visit the website http://micor.agriculture.gov.au

After clicking on the appropriate commodities group (noting logins are not required for fish, eggs and non-prescribed goods), click on the 'apply for access' link which will send a request for access to the department. The department will assess the application and, if the applicant is successful, issue a login and password.

Please note that the information on MICoR may not reflect recent changes to importing country requirements. The Department of Agriculture encourages all exporters to contact officials of the importing country, either

through the importer or directly, to confirm that their product meets the current requirements of the importing country.

Due to the August 2014 MICoR upgrade, some pages display the date of 'last update' as a date in July or August 2014. These dates were applied when the system was upgraded and therefore do not necessarily reflect the last date that the page was updated. Exporters should not rely on this date to determine when changes to importing country requirements have occurred. The department encourages all exporters to contact officials of the importing country, either through the importer or directly, to confirm that their product meets the current importing country requirements.
